

For the past 8 years I have had the honor of leading an outstanding residency program. I was fortunate to assume the position at a time that the program was thriving. With the continued support of Beacon Health System, we have grown from 24 to 27 residents and greatly expanded the family medicine center. The residents are learning in a state of the art facility with a simulation lab, expanded resident work area, and areas for exercise and rest. Our patients are being served in a beautiful clinic with radiology and advanced procedures on site.

While some things have changed, the continued pursuit of our mission has not. We continue to work to enhance the physical, mental and emotional wellbeing of the community. 




Susan Cheng, MD



Our Physicians AROUND THE WORLD

DR. JONATHAN DITTY



In February and March 2018 I had the opportunity along with my wife and two young boys to spend a month at Annoor Sanatorium for Chest Diseases in Mafraq, Jordan. The hospital was established to treat tuberculosis among the Bedouin of northern Jordan, a traditionally nomadic people group living throughout the Middle East known for their mastery of desert life as well as their cultural pride and warm hospitality. The hospital and


clinic also serves a growing population of Syrian refugees with one of the largest refugee camps just a few miles down the road. There were numerous cases of multi-drug resistant TB as well as a case of extensively-drug resistant TB often due to incomplete treatment courses as a result of war and lack of access to medical care.

I spent most of my mornings seeing patients in the clinic with my meager Arabic and a great translator. In the afternoons I rounded on inpatients with a team of amazing doctors from around the world including family doctors, pediatricians, and a pulmonologist. It was humbling to work alongside these incredible volunteer physicians and am thankful to have had the opportunity to spend a month learning from them during residency.

DR. SUSAN CHENG



I had the privilege of spending a one-month international rotation as a resident at ELWA Hospital in Liberia, Africa. ELWA Hospital is run by a mission organization called SIM. The hospital is known internationally as it was one of the major hospitals that treated Ebola patients during the 2014 outbreak that devastated several western African countries including Liberia.

I was very fortunate to connect with several missionaries from my church in Granger, Indiana and they introduced me to Ebola survivor and missionary physician, Dr. Rick Sacra. The first time I met Dr. Sacra, he gave me a big hug and told me that he had Ebola. At the same time, he told me not to worry because he was no longer contagious, and there began a great mentor-mentee friendship.

My trip to Africa was primarily motivated by my longtime desire to serve the African people. The desire to go to Africa arose during college when I heard about the HIV/AIDS epidemic in Africa and the medical care that they lack to meet the needs there. It was around that same time in college that I decided to become a physician and left my prior desire to study architecture. Since I started my path in medicine, I have traveled to many countries, including India, Asia and the Middle East but have never made it to Africa until now.

Africa through the lens of ELWA Hospital is an experience that I will never forget. The hospital's campus is located on the beautiful and ageless beach of Liberia looking out onto the warm Atlantic Ocean. I remember looking out to the ocean as the sun set on a calm sea that turned the sky into the most magnificent shade of purple, the juxtaposition of this picturesque sky with the knowledge of Liberia's devastating past burdens me deeply. Liberia has gone through two decades of bloody civil war and subsequently the Ebola epidemic. Children have been made into soldiers; wives have become widows, and daughters have been forced into prostitution. A country that was established by freed slaves of America, after the year 2016, was finally able to start seeing some meaningful changes. Despite their past, Liberians are incredibly welcoming and warm. Most of them spoke Liberian-English, which is essentially English with a heavy African accent. It took me a week working in the ER with an American missionary nurse to get used to the language.

My typical days consisted of going to the chapel early in the morning to pray with the hospital staff and worship in song together. I would attend morning rounds with the family medicine residents and attending physicians in the adult medical wards and obstetric ward. During the mid-morning, I would start outpatient clinic and would continue into the afternoon. On a typical day at the clinic, I would see



approximately 10-15 patients. At times the nurse would pull me aside to assess a wound that was complicated. Help was always needed in the ER, surgical ward, and obstetrical ward. ELWA has one x-ray machine and three portable ultrasounds that I used quite often. I scrubbed into as many surgeries as I could (and there were plenty). There was an American surgeon from Tennessee on her first assignment through Samaritan's Purse post-residency program who I did a lot of general surgeries with. Together we saw many cases as the result of complications from prior surgeries. A previously healthy 19-year-old who had an appendectomy surgical wound that got infected and was later mismanaged presented with sepsis and was in extreme cachexia. We found a total of 7-9 fistulas in the colon and had to resect a part of his colon. There were many of these experiences during my time in ELWA. I learned about the brevity of life and how precious each moment is. I had the privilege of learning from these missionary and African doctors. Their resilience and their strength under constant adversity inspire me. My short time there was made sweeter by the friendships made with the Liberians as well as the missionaries. I'm looking forward to returning to ELWA Hospital to serve again in a greater capacity in the future. I'm thankful that Memorial sent me to Africa to fulfill my longtime goal. I do want to encourage those who are interested in practicing third world medicine to come to ELWA Hospital to learn. It is truly a multifaceted hospital with great resources and a wealth of learning potential.

In January I had the chance to be part of a mission trip to Port-au-Prince, Haiti with a team from Memorial and Arizona. We worked under the St. Luke Foundation for Haiti and its founder Fr. Rick Frechette, DO. Meeting Fr. Frechette was inspirational; he has dedicated his life to the people of Haiti as a priest

in every ways imaginable, even returning to the US for a time to attend medical school out of necessity to be able to further serve. We operated as an outpatient surgery center and performed 85 cases in one week. This has been a life changing experience for me, as I have felt the desire to serve in underserved country for a long time, but never had the opportunity to do so. I thank the Memorial residency for this opportunity and look forward to the opportunity to serve again in Haiti.

DR. SERGIO SEAN SALÉS




Nestled among the misty Northern coastal foothills of Honduras' tropical rainforest, Mafraq is a rural critical access, full-service 15-bed hospital with an ER, two OR suites, and two private OB delivery rooms. I am ever so grateful to Memorial for providing me with the opportunity of serving

there as family physician for a month. The hospital's deft combination of shrewd resource stewardship and dedication to quality patient care was an ideal training ground in preparation for my work after residency at a rural practice and hospital. It was also an ideal setting combining relative independence, working at the top of my scope of practice, while still facilitating intentional learning, especially of tropical disease processes. My training at Memorial certainly equipped me to step into a full scope setting such as this and be confident and competent while doing so.

My time there consisted of a combination of seeing patients in clinic during the week, taking call in the emergency department overnight and on the weekends, delivering babies when on call, and rounding on my patients in the inpatient ward. Throughout these various practice settings, my greatest joy was getting to know and caring Hondurans from different backgrounds, but they were uniformly determined, generous, and kind. About half of my patients came by car, moped or walking from 4-12 hours away for the chance of receiving an appointment. The other half already had regular appointments scheduled; very few of these no-showed. Whether it was a routine visit for high blood pressure, or diabetes or new diagnosis of cancer, everyone who came was grateful to be seen.

Overall, my time at Loma de Luz gifted me with a clear sense of perspective. It broadened my love for people, reinvigorated my passion for family medicine, and renewed in me a clear sense how blessed we are in the United States. Because of this trip and the training I have received at Memorial, I am confident that rural practice will be a good fit for me and that international medicine will be a vital part of my future practice.

Procedural Training Remains a Core Part of the Fellowship Program

MSK ultrasound training remains a strength of the sports medicine fellowship program and is now being recognized by governing bodies as a core requirement in the education of sports medicine fellows. Joint injections and fracture care are other skills being taught to the residents and fellows. Also at the Sports Medicine clinic, innovative procedures such as PRP and percutaneous tenotomy continue to be performed, and fellows are graduating the fellowship well-trained to go out into practice and help their patients with the use of these techniques.

Annual Training for Emergency Preparedness Prior to Fall Sports Season

In a session coordinated by Beacon Sports Medicine, Residents and athletic trainers from both the Memorial and Saint Joseph systems participated in a practice session for the care of a spine injured athlete on the athletic field. Volunteers suited up in football gear, so that the removal of the gear could be practiced prior to spine boarding the patient. This session is quite beneficial as the residents and athletic trainers in both systems are often both present at the games, and training together gives our community's student athletes a higher level of safe participation.

Presentations at AMSSM and ACSM National Meetings

At the annual AMSSM National Meeting, Sports Medicine fellow Will Paulson, MD and resident Mitch Daugherty, MD presented interesting cases in the form of poster presentations. First year resident Brent Pickett, DO presented a poster highlighting his original research concerning musculoskeletal injuries in classical musicians.

Local High Schools and Two Colleges in South Bend Well Served by Beacon Certified Athletic Trainers and Physicians

The relationship between the South Bend Community School Corporation and Beacon Sports Medicine continues to be strong. Memorial provides certified athletic trainers to Riley, John Adams, Clay, and Washington High Schools. Laville High School and Edwardsburg High School also have ATC's provided by Memorial Hospital. Drs. Linda Mansfield and Michael Messmer, sports medicine fellow Dr. Will Paulson, as well as residents Drs. Senaka Ratnayake and Tom McGinn provided sideline and

training room coverage for these schools. In addition, all the residents participate yearly at the schools to provide preparticipation physicals to the athletes. Drs. Mansfield and Paulson visited Holy Cross College and IUSB weekly during the school year to attend to injured athletes. These schools also had physician coverage for their basketball games provided by Drs. Mansfield, Messmer, Tucker Balam, and several of the residents. This is a great opportunity for the residents to get experience providing medical coverage for collegiate level sporting events.

Sports Medicine Fellowship Match

The Sports Medicine Fellowship, which is a collaboration between the family medicine residencies at Memorial Hospital and St. Joseph Regional Medical Center, matched two fellows for the class of 2018-2019. Thomas Finn, DO and Patrick Walsh, MD will be joining us on July 1st for a busy year working in the sports medicine clinics, at the high schools, with athletes at several NAIA schools in town, and with the University of Notre Dame to further their sports medicine knowledge and experience.

Sunburst Medical Tent Volunteers Well Prepared to Handle Casualties of the Race

Attending physicians, fellows, residents, and medical students were among the volunteers in the medical tent at the Sunburst Races this year. Under the medical directorship of Dr. Mansfield, they were prepared to treat everything from minor injuries requiring only first aid to heat stroke, which would be treated in ice immersion baths on site. The weather was favorable, and it was another year of keeping all runners safe. Both sports medicine fellows were present as well as residents Jon Aubry, MD, and Tom McGinn, DO.



2018 Baldwin Award

The Arnold P. Gold Foundation and the Accreditation Council for Graduate Medical Education (ACGME) recognized Memorial Hospital of South Bend as a winner of the 2018 DeWitt (Bud) C. Baldwin, Jr. Award. Memorial was one of two hospitals honored for fostering a respectful and supportive learning environment for graduate medical education. The awards were presented in Orlando, Florida, as part of the 2018 ACGME Annual Educational Conference: Engaging Each Other: Transformation through Collaboration.

"Our two 2018 Bud Baldwin Award winners serve as examples of ideal learning environments, where a culture of humanism can be seen throughout their systems," said Richard Levin, MD, President and CEO of The Arnold P. Gold Foundation. "By training young physicians in a culture of respect and compassion, Excelsa Health Latrobe Hospital and Memorial Hospital of South Bend are making a powerful difference for both their own patients and staff but also for the healthcare organizations where these residents will work in the future."

During the site visit, institutions are asked to demonstrate the professionalism and success in addressing medical education issues and implemented programs to support their application. The site visitors interviewed and interacted with residents to get their perspective on the culture of the residency and hospital.

The ACGME and Gold Foundation DeWitt (Bud) C. Baldwin, Jr. Award originated in 2016 to highlight institutions with accredited residency/fellowship programs that are exemplary in fostering a respectful environment for medical education training. The award also seeks to highlight the focus of patient-centered care and compassion throughout the institution.






CURRICULUM

Obstetrics Program

Our residency program has a long tradition of offering an outstanding obstetrics experience within the framework of a traditional family medicine residency curriculum. Our graduates have gone on to incorporate obstetrics into their practices and utilize those skills at home and abroad. Our residents provide 24-hour coverage of the Memorial Childbirth Center, a busy unit that averages 200+ deliveries monthly. They are the frontlines for triage, labor, delivery and our antepartum unit seeing nearly every patient arriving to the unit. As Memorial Family Medicine Residency is unopposed there are no other residents competing for this experience. In addition to the inpatient experience, our residents care for approximately 400 women per year at Beacon Medical Group E. Blair Warner Family Medicine Center.

OB Fellowship

Since its inception in 2003, we have been pleased to offer a yearlong Family Medicine Obstetrics Fellowship to one candidate per year. The goal of the fellowship is to expand upon the education the resident has received and to teach surgical obstetrics; including cesarean sections, tubal ligations, and advanced ultrasound skills. This exposure to higher risk obstetrics and the procedural skills they develop are a great asset to the communities in which they practice. The structure of the fellowship is designed in such a way as to allow continued exposure to the breadth of family medicine, and to maintain a broad and current knowledge base. Each fellow is expected to create and present a research project. The fellow serves as a mentor, and an active member to the educational team, teaching residents in the clinic and the hospital.

Health Services Management

An Introduction

The Health Services Management (HSM) curriculum was developed in 1997 as a partnership with Indiana University South Bend. A resident in this curriculum extends their residency by one year to allow time to earn a Master of Public Affairs in Health Services Management degree. During the HSM Fellowship year there is ample opportunity for electives, which has allowed graduates to tailor their curriculum to make their degree most useful for the practice opportunities they will pursue after graduation.

Accomplishments/Successes

Fifteen residents have graduated from the Health Services Management curriculum. Currently, there are three residents enrolled in the HSM curriculum: Senaka Ratnayake, MD, PGY-IV, Rachel Schuster, DO, PGY-IV, and Katherine Callaghan, MD, PGY-II. Dr. Schuster, like six prior HSM 3rd year residents, served as the Chief Resident last year. Of the first 15 residents who have graduated from the HSM curriculum, four have won the coveted Bristol-Myers Squibb Award.

Dr. Jason Marker was the inaugural graduate from this program in 2002 and, after 15 years in rural private practice, returned to Memorial Family Medicine Residency in 2017 as an Associate Director. He serves as the Clinic Director for the E. Blair Warner Family Medicine Center and as the faculty advisor to the HSM program. Dr. Marker is a Past President of the

Indiana Academy of Family Physicians, a Past President of the American Academy of Family Physicians Foundation, and a Past Director of the American Academy of Family Physicians. He currently serves as the Practice Transformation Core Team Leader for Family Medicine for America's Health.

In 2010, Dr. Brandon Zabukovic, who graduated from the HSM curriculum in 2006, was honored as one of the first winners of the Pfizer Teacher Development Award given by the American Academy of Family Physicians Foundation. He is the medical director of the Beacon Medical Group Centennial Neighborhood Health Center and practices with two other HSM curriculum graduates, Drs. Leah Craft and Michael Kozak. Dr. Zabukovic provides staffing support and regular didactic education at the residency and leads the Michiana Opioid Task Force which is working to develop a community-wide approach to combating the opioid epidemic in northern Indiana. He is advising the Memorial Residency on the development of its own Suboxone Program for its patients' recovering from opioid addiction.

Dr. Benjamin Adkins graduated from the HSM curriculum in 2004 and practices in Pullman, Washington where he utilizes the procedural skills learned at Memorial Hospital to provide Cesarean sections and colonoscopies in addition to providing full spectrum family medicine to his patients.

Many HSM graduates still practice at Memorial Hospital where they share their expertise with

the current resident physicians through a variety of teaching venues. Dr. Keyna Martinez, who practices at Beacon Medical Group Lakeville, frequently lectures on practical patient management topics at noon conference but also hosts many residents in her rural family medicine practice. Dr. Marion Mahone is one of the Academic Hospitalists who provide inpatient adult medicine teaching full-time on the Staff Medicine service on an alternating basis with program alum Dr. Matt Reed.

The residents in the HSM curriculum provide noon conferences on practice management topics once or twice in their third and fourth years of residency, and contribute significantly to the overall teaching of practice management in the curriculum. These fourth year residents function as junior faculty by staffing the E. Blair Warner Family Medicine Center clinic, providing adjunct teaching support on the Staff Medicine service, and sharing result of system-based research that they are doing as a part of their Master's degree with their peers.

The alumni of the HSM curriculum have branched out into many areas of patient care, community leadership and health care administration and attribute their ability to do so to their training experience at Memorial in the HSM program. They feel blessed by the Beacon management team's long-standing support of this program and their willingness to create opportunities for this advanced educational environment to flourish.

In 1977, Dr. Timothy Thut graduated from the Memorial Family Medicine Residency program and started Goshen Family Physicians. Dr. Amanda (Mandy) Schmidt, a 2011 graduate, has a special interest in pediatric patients and hospice care. Outside of private practice, Dr. Schmidt enjoys working at the Center for Healing and Hope, a clinic that works with the underserved / uninsured and provides social services particularly to Elkhart County's large immigrant populations. She enjoys finding ways for this particular organization and their private practice can best serve the community.

Lastly, Dr. Katie Michalczyk, a 2012 graduate, has a strong interest in Women's Health and continues to practice full spectrum with outpatient, inpatient and OB populations. Beyond the patient care, Dr. Michalczyk is

also involved in work with the Center for Hope and Healing, medication safety committees and the ACO Medical Management and Quality committees. In the absence of an office manager, Dr. Wait provides assistance with financial planning while Dr. Michalczyk is integral in personnel management and has become a part of her job that enjoys.

The Memorial Hospital Family Medicine Residency currently has a full accreditation and expects to be surveyed by the ACGME in 2019. A detailed mid-cycle internal review of the residency program was performed in the 2011 that insured substantial compliance with the current ACGME standards.

Resident schedule and supervision were updated in 2011 and the program continues to maintain compliance with the ACGME Duty Hours Rules and the requirements for supervision. Duty hour reporting was reviewed by the residency and the GMEC. It was determined that the resident schedule and requirements continue to insure substantial compliance with current ACGME standards.

Milestones were introduced by the ACGME to evaluate resident physicians. These provide a framework for the assessment of the resident physician in key dimensions of the elements of physician competency in family medicine. Our program has implemented milestones as part of our evaluation of every resident in our program.

The residency continues to expand the use of an electronic evaluation system. New Innovations software allows for the electronic evaluation of rotations and resident performance including the milestone based system implemented with NAS. The evaluations are now ACGME Milestone based and progressive through the 3 years of training. Our residents continue to perform exceedingly well on evaluations and on the annual in-training exam on which our 3rd year residents exceeded the national average score during their training.

The residents continue to be responsible for patient care in both the hospital and outpatient setting. They are also members of all of the medical staff committees and actively participate in the morbidity and mortality conferences that improve patient safety and quality of care. The revised curriculum meets all of the requirements of the Family Medicine specific requirements effective on July 1, 2016. There have been no citations for patient care issues.

Program graduates continue to be pleased with their training and excel in their careers as documented elsewhere in this report. The annual survey of graduates was presented to the GMEC.

The experienced faculty continues to demonstrate excellence in teaching and to develop their teaching skills. The faculty development program included residency specific quarterly events as well as attendance at national meetings.

In summary, the Memorial Hospital Family Medicine Residency continues to be an excellent residency training program that is proud of the accomplishments of the residents, faculty and alumni.


